

Incentive Fund for RAP Sponsors/Employers Renewed for 2023!

The Hub is excited to share that the Incentive Fund available to support RAP sponsors/employers in growing existing and developing new Registered Apprenticeship Programs (RAPs) has been renewed for 2023!

The fund helps sponsors/employers offset the costs of launching RAPs, providing training to apprentices, and supporting resources and tools that are not available for free, such as tuition for Related Training Instruction, training for mentors, and equipment.

Incentive Fund applications are being considered on a rolling basis until November 1, 2023. The amount of the incentive varies based on the number of apprentices the sponsor/employer commits to enroll.

The Hub is happy to partner with General Motors PPO North to train a new cohort of 50 electricians, die makers, and model makers through their Skilled Trades Apprentice Readiness Certificate program. The Hub incentive funds will help in developing and updating RAP curriculum, paying training instruct tor fees, and creating additional

teaching materials.

General Motors allocates substantial resources and funding to their RAP and technical training for all skilled trades and has created a Technical Learning University Center (TLU) which operates as a college for all General Motors employees' technical upskilling, including Apprentices. The TLU is in Warren, Michigan, and all apprentices come to the center to fully immerse in training activities which then allows them to take the skills they learn back to their respective locations.

Where We've Been

2022 was an excellent year for the Hub as a new U.S. Department of Labor intermediary, with the Hub team exceeding its goals for registering new apprentices and performing outreach to hundreds of employers, educational institutions, workforce development boards, and career seekers. Last year, the Hub team built a strong foundation on top of which it seeks to grow.

This year is all about taking our work to the next level, expanding the Hub network to even more states to diversify the workforce and prepare employers to meet changing labor demands in supply chain automation and related industries. As a result, in the last few months, the Hub team has been focused on strategic planning for 2023 and has recently updated many of its processes and procedures as well as all marketing and outreach collateral.
